## **Introduction**

Gujarat Gyan Guru Quiz (G3Q) Launch programme is going to be organized on 7<sup>th</sup> July 2022 at Science City, Ahmedabad, Gujarat in co-ordination with the Ministry of Education, Government of Gujarat. G3Q endeavours to provide a platform to students and citizens alike through participation on the quiz for projects, programmes, schemes and achievements. Approximately 5000 participants are expected for the event.

[Note: The purpose of this document is to select the Event Management agency for the above mentioned event.]

The Agency need to submit the quotation in three different sealed covers which shall be titled as instructed below:

### **Cover:**

**“DOCUMENTS COVER FOR WIFI CONNECTIVITY WITH STRONG, HIGH SPEED, SEAMLESS INTERNET CONNECTION at SCIENCE CITY”**

#### **Cover 1: “EMD COVER”**

This cover shall comprise of deposit of Rs.45,000 in the form of DD as an EMD in favour of Knowledge Consortium of Gujarat payable at Ahmedabad.

[NOTE:- The agency that has not submitted EMD will not be eligible to participate for the further process, hence the other covers will not be opened]

#### **Cover 2: “TECHNCIAL DOCUMENTS COVER”**

This cover shall comprise of all documents related to eligibility criteria and Annexure 1 duly signed and stamped on each page to be submitted with the self-attested/ signed and stamped supporting documents.

[NOTE:- Agency not fulfilling the criteria will not be held eligible to participate in the further process of Price/Financial Bid]

#### **Cover 3: “PRICE BID COVER”**

This cover shall comprise of Annexure 2 duly signed and stamped on each page of the Annexure.

All above cover shall comprise of rates as per scheduled / attached format, duly signed and stamped on each page to be submitted with the self-attested/ signed and stamped supporting documents.

The cover shall be super scribing it to "The CEO, Knowledge Consortium of Gujarat, at 'Pragna Puram Campus', Near L D College of Engineering, Opp. P.R.L., Ahmedabad - 380 009 through courier/R.P.A.D./Speed Post/in Personal on or before 6<sup>th</sup> July, 2022 up to 10:00 hrs.

This outer envelope shall bear the submission address, and the title as instructed above, and be clearly marked "Do Not Open, Except in Presence of the Official Appointed". KCG shall not be responsible for misplacement, losing or premature opening if the outer envelope is not sealed and/or marked as stipulated. This circumstance may be case for rejection of proposal. If the Financial Proposal is not submitted in a separate sealed envelope duly marked as indicated above, this will constitute grounds for declaring the Proposal non-responsive.

Any proposal received by the Client after the deadline for submission shall be returned unopened.

At any stage of the process, the decision of the KCG official will be held final. KCG official is authorized to make any changes in the process or cancel the process at any point of time during the entire process.

## Terms of Reference

### **1. SELECTION CRITERIA FOR BIDDERS**

#### **A. Evaluation**

<b>1</b>	Availability of Service Centers: Bidder/OEM must have a Functional Service Centre in Ahmedabad/Gandhinagar.	Documentary evidence required.
<b>2</b>	The tenderer/ bidder should have experience of having successfully completed/ implemented project of installation, configuration and maintenance of LAN/WIFI setup to clients in last 3 years from the date of inviting tender as: a) at least one work order of LAN/WIFI setup to clients of not less than Rs. 15 Lakhs	Work order & work completion certificate – validated by buyer department
<b>3</b>	The bidder must have an average annual financial turnover of at least 10 lakhs in last 3 years as on the date of notice inviting tender.	Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant / of audited balance sheet / profit & loss statement indicating the turnover details for the relevant period shall be uploaded.
<b>4</b>	EMD: deposit of Rs.45,000/- in the form of DD	EMD EXEMPTION: The bidder seeking EMD exemption, must submit the valid supporting document for the relevant category.

#### **B. FINANCIAL BID**

- a. Bidder shall fill up entire price bid along with final amount.

Authority reserves the right to make the appointment of the Successful bidder subject to such further terms and conditions as it considers appropriate in relation to the Tender process and/or the provision of the Services. Authority shall not be obliged to give any reason(s) for the selection and/or rejection of any Proposal or any part thereof.

Authority reserves the right, at any time and in its absolute discretion, accept or reject Proposals (or to permit any bidder to resubmit its Proposal, such that Proposal fails to meet any or all of the Criteria and/or the Requirements), to pursue negotiations with any number of bidders, to withdraw from negotiations with any bidder at any time and to suspend, discontinue, modify and/or terminate the Tender process at any time.

### **C. Deciding award of contract:**

Quality and competence of service shall be considered, as the paramount requirement.

## **2. Scope of the Work:**

- i.** The service provider must provide strong WIFI connectivity with seamless internet connection to handle online quiz playing for approximately 5000 participants through Web Portal throughout the Quiz launch programme.
- ii.** This includes installation, commissioning, testing & complete maintenance of strong WIFI connectivity with seamless, high speed internet connectivity for one day on 07/07/2022 at Science City, Ahmedabad, Gujarat.
- iii.** The service provider should provide strong, high speed, seamless Internet facility at the venue for the event day, as this quiz competition is going to be held in online mode through web portal among 5000 participants.
- iv.** As the participants in this contest are from all over the Gujarat so the contractor must ensure that the proper high speed internet connections must be available on 07/07/2022 without fail.
- v.** The connectivity will be through dedicated Internet line/WI-FI.
- vi.** The hardware and software required for the establishment of fully functional lines will be provided by the bidder. The minimum guaranteed bandwidth required from the Bidder is 1 GBPS.
- vii.** Any change that is needed to be carried out in the existing setup shall be carried out after approval by the competent authority of KCG and Science City. The same shall be informed in advance so as to plan the downtime/impact to the end users. The work shall be carried out as per KCG compliance and requirements communicated to the vendors from time to time.
- viii.** The service provider shall maintain the sufficient Spares for maintaining required uptime guarantee for that one day.
- ix.** Before the six-hour event begins, testing must be finished in presence of KCG authority and submit testing report to KCG.

## **3. General Terms and Conditions**

- i.** KCG shall not be responsible for damage to the systems due to external circumstances such as earthquakes, floods, fires, riots etc.
- ii.** If there is a need to shift the ISP router or end point to any other location/room from the current location, the service provider needs to configure entire setup at free of cost during the day of the event.
- iii.** The Internet Service Provider should provide one nodal person for this project.

#### **4. PAYMENT TERMS**

- i. Payment for Services shall be made by the accounts Department in Indian Rupees.
- ii. The total amount shall exclude GST (as applicable) or any other Government taxes.
- iii. No payment will be made for any kind of incomplete implementation of work.

#### **5. Performance Bank Guarantee(ePBG)**

- The successful L-1 vendor have to submit performance Bank Guarantee(ePBG) @ 5 % of Total L-1 Price for one (01) Month duration within 24 hrs of receiving order.
